






## What are we trying to achieve?



### Corridor Management Objectives

- Incorporate local needs in a focused and effective way
- Coordinate & Leverage Asset Management Investments
- Identify practical, short term projects
- Identify longer term needs
- Integrate into maintenance, projects and permitting
- Annual Status Meetings to monitor progress and changes





#### Goals

#### **Project Goal**

- Identify practical recommendations that are possible to implement in the short-term in combination with asset management investments such as paving and bridge projects
- Identify longer-term needs that may be addressed through other AOT and municipal programs.

#### **Goal for Today's Meeting**

- Share information already collected about the Corridor
- Share brief overview of improvements included in the 2021-2022 Paving Project
- Gain additional knowledge about the corridor from Stakeholders



## Why am I here? Three types of input

- 1. **VTrans** data and staff
- 2. **Partners** other state agency, town, RPC or other similar entity which can help us to identify issues along the corridor, and may also be a *partner* is helping to address some of the issues
  - ANR, VEM and others
  - Southeast Vermont Transit and GMCN
  - BCRC and WRC
  - Towns on the corridor
  - Green Mountain National Forest

- 3. **Stakeholders** people who use the corridor
  - Towns near the corridor who use it often
  - Businesses near and along the corridor
  - Residents near and along the corridor
  - Advocacy groups near and along the corridor
  - Members of the WRC and BCRC Transportation Advisory Committees (TACs)



### Vermont Route 9 – Orientation and history

- Key east-west connector
- Officially named "Molly Stark Trail" in 1967
- Key communities Bennington, Wilmington, Brattleboro

#### Major projects

- Major reconstruction between Searsburg and Wilmington in early 2000s
- Installation of chain up areas on western side


# Paving Project




### Paving project (Wilmington to Brattleboro)

- Bid in Winter 2021
- Construction over 2 seasons:
  - Drainage and ancillary work in 2021
  - Reclaim paving in 2022

## What is included in the project?



- Road being reclaimed (grind up the pavement and some of the subbase, then rebuild the pavement on top)
- Working on drainage for all but the last mile of the project in Brattleboro
- Shoulders being addressed where possible
- Road slant (banking) issue will be dealt with along most of the paving project



### Notable improvements included

# South Rd intersection (Marlboro)

 Left-turn lane being installed

## Area near Marlboro Elementary School

- Truck climbing lane length evaluated
- Better signage
- Remove sight distance issues in state ROW
- Recommendations for sight distance improvements outside state ROW

#### Turners Corner near Hamilton Rd (Marlboro)

- Road slant (banking) issue addressed
- New signs installed
- Centerline rumble-strips will likely be installed
- Tree clearance and minor slope work where possible
- Partner opportunity could Hamilton Road be one way or closed at the western end?

#### West Brattleboro (Sunset Lake Rd to Edward Heights Rd)

- Speed limit change (40 35mph) approved by VTrans Traffic Committee
- Bike lanes will be marked
- Crosswalk to be installed near Winding Hill Rd
- Evaluated crosswalk near Cumberland Farms/ Dunkin Donuts but not being installed
- Flashing beacon (RRFB) proposed near Edward Heights



## Traffic volumes over time (Route 9 in Marlboro, just east of Town Hill Rd)






#### Traffic

Winter traffic\* has considerable variations with highs on Fridays

- Average daily traffic 4,100
- Highest traffic Fridays 5,100
- Friday of President's Day weekend -5,800
- Lowest traffic Tuesdays 3,600

- Route 100 South intersection in Wilmington (3005)
- Augur Hole Road and other local roads used as detours (3016)

- Stormwater improvement needed near Dunkin Donuts in W. Brattleboro (3017)
- Wildlife improvement needed for large culvert in Searsburg (3020)\* and other locations
- Resiliency improvement needed at Marlboro/ Brattleboro townline (3039)\*
- Bridge 51 near Westgate Drive in W. Brattleboro (3014)
